



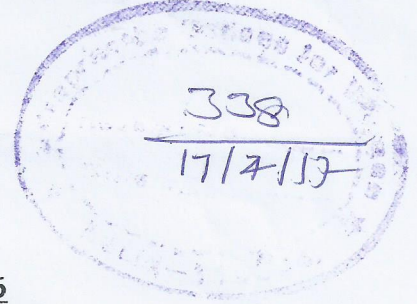

As you are aware, University of Delhi awards 20 Entrance based Scholarships (10 each for resident and non-resident students) on the basis of a Competitive Examination. The value of the Scholarship is Rs. 300/- per annum each tenable for three years for pursuing a course of study for an Honours Degree (B.A./B.Sc/B.Com) w.e.f. the admission session 2016-17.

Rules relating to All India Entrance Scholarship Competitive Examination

1. There shall be Twenty Scholarships each of the value of Rs. 300/- per mensem.
2. The Scholarships shall be awarded in order of merit to be drawn on the basis of results of the Competitive Examination held each year for the purpose.
3. The Examinations shall be open to the students who have passed any of the undernoted examinations in the year in which the Competitive Examination is taken:-
 - (a) The Senior School Certificate Examinations under 10+2 pattern of education of the Central Board of Secondary Education New Delhi in the first division, or an examination recognized as equivalent thereto, obtaining not less than 60% marks in aggregate.
 - (b) The Indian School Certificate Examination under 10+2 pattern of education of the Council for the Indian School Certificate Examination in the first division obtaining not less than 60% marks in aggregate.
4. Application on the prescribed form for admission to the above Examination shall be made to the Dean/Controller of Examinations within the prescribed period as indicated on the top of the form.
5. The Examinations shall consist of the following papers:-

(i) Essay, Composition and Precis-Writing.....	One Paper	100 marks
(ii) General Knowledge.....	One Paper	100 marks
(iii) Any two of the following subjects.....	One paper	100 marks each.

 - (a) English Literature or Hindi Literature or Sanskrit Literature or Urdu Literature or Literature of Arabic or Persian or Assamee or Bengali or Gujarati or Kannada or Marathi or Malayalam or Manipuri or Oriya or Punjabi or Sindhi or Telugu or Tamil, etc.
 - (b) Indian History or British History
 - (c) Economics
 - (d) Sociology
 - (e) Commerce
 - (f) Geography-General and Commercial
 - (g) Political Science
 - (h) Elements of Psychology or Elements of Logic
 - (i) Mathematics
 - (j) Physics
 - (k) Chemistry
 - (l) Biology
 - (m) Home Science
 - (n) Music
 - (o) Accountancy

Note :

- (a) Candidate who have joined B. Sc. (Hons.) Course offer any two science subjects in addition to compulsory papers I and II.
 - (b) Candidates shall have the option to write answers either in English or in Hindi in the subjects other than English and General Knowledge.
 - (c) The questions set in the subjects will be of a general character and will be wide enough to give candidates a reasonable opportunity of showing both their knowledge in the subjects and the capacity for answering examination questions.
6. Scholarship holders will be required to pursue a regular course of study for Honours Degree in the University.
 7. Not more than one Scholarship will ordinarily be awarded for one subject of study prescribed for the B.A., B.Sc. or B. Com. Honours courses but if no candidate qualifies for the Scholarship for anyone of these subjects, the Scholarship may be awarded in order of merit to qualified candidates in other subjects.
 8. The Entrance Scholarships are tenable from May each year for three years.
 9. The Scholars shall be declared selected in order of Merit.
 10. If any of the Scholars does not accept, or having accepted ceases at any time within the first year to be a student of the University the Scholarship may be re-awarded to the candidate standing next in order of merit for Scholarships in the same category.
 11. Each Scholar shall be notified of his selection as soon as the awards have been made. A scholar not intimating to the University in writing of his/her acceptance of the Scholarships or not joining a College of the University within one month of the date of the University's Letter, shall forfeit his/her Scholarship.
 12. If it appears at any time to the Academic Council that the progress or conduct of a Scholar has not been satisfactory, his Scholarships may be suspended forthwith.
 13. Acceptance of any other scholarship simultaneously by a scholar is not permissible.
