Enrolment Procedure for Swimming Pool Membership

1. Forms for Swimming Pool membership are made available at the College gate.
2. Members need to fill the form and get them medically certified.
3. This form then will be counter signed by the contractor/ supervisor responsible for and managing the Swimming Pool
4. **Fee deposit Procedure:-**
 - a) After getting the form signed by the contractor/ supervisor member has to deposit the fees in the bank and given the bank acknowledgement copy to the contractor/ supervisor.
 - b) Contractor will fill the admission slip in the triplicate (viz A,B,C) and give one of its copy (B) to the member in exchange of Bank acknowledgment slip.
 - c) Copy C and Bank acknowledge slip will be stapled with filled form and will be deposit in the College Account's Office record
 - d) Copy A will remain in the booklet which will be kept with the contractor for their record.
5. For renewal the same procedure will be followed. In place of the form, there will be a renewal slip.
6. Contractor's/ supervisor's signature on the form will be valid only for one working day for fees deposit. The member would have to fill the form again, in case he/she missed the day.
7. No cash transaction for membership allowed at the Swimming Pool.



NOTICE

1. The College reserves the right to refuse entry to any person/s seeking admission to the swimming Pool, if it feels threatened and harassed in any way.
2. Only regular membership is offered. There is no provision for casual swimming against coupons.
3. Users are to wear proper lycra Swimming Costume and cap.
4. Children below 5 years and less than 4 ft. height are not allowed in the swimming pool, Minor members (12 years and less) must be accompanied by an adult.
5. Only one adult is permitted as accompanying person for minors.
6. Males will not be permitted as attendants in the 'women & children' slot.
7. Members swim at their own risk and in case of accidents, College will not be responsible in any way.
8. Membership cards must be shown at the College Gate at the time of every entry and also at the swimming pool.
9. Members must sign the "In" and "Out" columns in the register for every entry and exit from the pool.
10. Swimming pool will be closed on all Sundays and gazette holidays. No separate notice will be issued by the College in this regard.
11. Users and potential users are cautioned about maintaining the decorum of the educational institution for women at all time.
12. The College reserves the right to refuse entry to outsiders at the College gate itself, for security reasons.

IMPORTANT NOTICE FOR SWIMMING POOL USERS

1. All queries will be at the College entry gate, including sale of forms. Only members will be permitted entry into the college premises.
2. Groups will be formed on first-come-first-served basis. Preference for membership of the swimming pool will be given in the following order:
 - I.P. College enrolled students
 - I.P. College staff
 - University students and staff
 - Community on first-come first serve basis
3. Please note that the forms are to be routed through the authorized person at the pool.
4. There will be no adjustment for missed sessions and for timings.
5. There will be **no refund of fees** under any circumstances whatsoever, or the transfer of membership. The College will not entertain such requests.
6. College authorities will not be responsible for any loss of personal belongings and valuables at the swimming pool.
7. Swimming in the Pool is at the user's risk. Only one attendant for minor children will be permitted on the premises.
8. The use of the Swimming Pool and entry into the college premises is strictly governed by the disciplinary authority of Indraprastha College for Women. Public is requested to cooperate.
9. Members are required to use the path indicated to go to the pool and **Not** through the College building.
10. There should be **NO LITTERING** in the College premises.
