2. The eligibility qualification prescribed for appointment /Nomination for the post of Vice-Chancellor, Tamil Nadu Music and Fine Arts University, Chennai is as follows:-

An eminent academician with Doctoral Degree in Music / Fine Arts / Performing Arts with at least 10 years of teaching and research experience at the level of professor with national / international level achievements in the field of Music / Fine Arts / Performing Arts and administrative experience in appropriate bodies.

Eminent professional scholars with Doctorate or Honorary Doctorate qualification in Music / Fine Arts / Performing Arts with at least 10 years of high levels of competence and national / international level recognitions in the area of Music / Fine Arts / Performing Arts / administrative experience in appropriate bodies are also eligible.

The term of office to the post of Vice-Chancellor is for three years (provided that a person appointed as Vice-Chancellor will retire from office, if, during the term of office or any extension thereof, he/she completes the age of 70 years).
