- 3. i) Confirmed the Minutes of the Governing Body meeting held on 28 February 2022, which were already circulated.
 - ii) Confirmed the Minutes of the Governing Body meeting held on 10 May 2022.
 - iii) The following are listed as matters arising out of the Minutes dated 10 May 2022:
 - a) Reported that as per direction in the GB meeting dated 10 May 2022, the College has sent the Resolution regarding omission of Indraprastha College for Women in the list of Milestones in the Centennial Bulletin released by the University of Delhi, on 11 May 2022.
 - b) Reported that as per direction in the GB meeting dated 10 May 2022, the College has sent a letter to the University of Delhi on 11 May 2022 regarding non-inclusion of the B.Sc. (H) Environment Science course in the University of Delhi's Bulletin of Information, as sanctioned by the University, to run the course on Self-Financing mode on 14 September 2021 vide its letter No. CB-II/260/New Courses/IPC/227.
 - c) Regarding Part-II-B, Para-6 in the Inspection Report received from the Office of the Director General of Audit (Home, Education and Skill Development), the Governing Body of the College observed that it reserves the right to determine the terms of engagement of all personnel in the Department of Multi Media and Mass Communication including faculty and experts, as per the course requirement. The course is a Self-Financing course and no other fund from any source has been received or envisaged for it. IP College is the only one in the country to run this course and there is no Rule and Regulations notified by the UGC or University of Delhi in this regard. Thus, the terms and conditions of Mr. Gagan Gera's appointment, made as per due process, may be reiterated as an appeal to the CAG in respect of its observations in the case of the appointment of Mr. Gagan Gera, also onwards of 2018.
